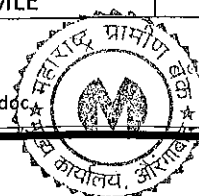

We are pleased to inform you that you have qualified for appointment as Officer Junior Management Grade I in Maharashtra Gramin Bank. However, your appointment as Officer Junior Management Grade I is subject to the certificate of Medical fitness given by the District Civil Surgeon or Medical Officer appointed by Bank, as well the acceptance of this offer unconditionally on following terms & condition;

1	You will be appointed as Officer Junior Management Grade I on probation in grade/ pay (Rs. 23700 - 980/7 - 30560 - 1145/2 - 32850 - 1310/7 - 42020) w.e.f. date of joining at the Branch / Office wherever you have been posted.
2	You will draw a pay of Rs. 23700/- (Rs. Twenty three thousand seven hundred only) per month in the scale as stated above. You will be eligible for Dearness Allowance, House Rent Allowance and Other admissible allowance as per service rules framed by the Bank from time to time.
